Course work prepares students for actual situations using up-to-date equipment and software. Additional topics include a review of basic accounting concepts and the creation of a company using QuickBooks.

Additional topics include: A review of basic accounting concepts, payroll transactions, and the creation of a company using QuickBooks accounting.
