#### 1.1. Feedback Fruits

- Craig Donahue presented his funding request; Feedback Fruits It is now stack approved. Started out as a pilot program; but it didn't meet certain qualifications. Some faculty has been using it. Will meet Title 5 regulations.
- Craig will send out the power point.
- One year license for \$25,000.
- With the new round of GP funding, the focus is on making institutional change and supporting the student Equity Plan. This program can increase student engagement and improve achievement and success. The DE Team would support the implementation and integration.

#### 2.1. GP Focus

- How to recreate Pillar Teams
- VP Baker and VP Martinez Garcia have had discussions that they would like me to share with you:
- Guided Pathways to shift our focus primarily into supporting enrollments as we restructure Guided Pathways.
- ❖ Re-create our Pillars Each Pillar will need to have a slightly different focus or goal in mind. Need to create four different goals and pathways that would support, facilitate, and improve enrollment.

**Discussion**: Amanda: GP is already in line with enrollment. Then persistence and completion. The State is also really pushing the integration of equity and guided pathways. DEIA needs to be part of it. Pillar One stopped basically by the complications of the website; so we had to pause until there was a website re-design.

- ❖ If we recreate the Pillars with enrollment in mind, we need to be re-creating them with equity, diversity, inclusion and access in mind.
- Suggested to start with a couple of big group sessions to take in all of the information: what are we looking for, what is the goal. Then do group work, then breakout groups.

#### ❖ Matt Summarized:

- Reconvene to reconnect with a group of interested individuals on campus that want to be part of Guided Pathways and have some conversations with groups about different projects.
- Those groups would discuss what would be valuable to support enrollment as well as the inclusion and access and from there, based on the projects, individuals can join different projects to help support that vision.
- During the first kick off for Guided Pathways, we looked at our data and we had hard conversations; then we focused on the projects. We need to do this again.
- Funding Requests going forward: Funding Requests will need to be for one academic year. If it is something ongoing, then another Funding Request needs to be submitted at the start of the next fiscal year.
