Meeting Minutes

3. Information/Discussion Items

3.1 Vision Resource Center Update – Greene/Roa

- COD is integrating into the Vision Resource Center Platform.
- Many tools will be available on this platform, including the ability to customize.

3.1.1 Campus Mobile App

- Ideas for a campus mobile app are being discussed.
- Donna Greene demonstrates the functionality of a health clinic's mobile app.
- David Bashore asks if we can involve the CIS department to help; make it a student project.

3.2 Exposing Students to campus services in new ways

- The campus mobile app being discussed could include access to student services information. Example: A student is referred to math tutoring, that student walks outside and needs to know where this service is located.
- Financial Aid and Admissions are looking at putting in a chat-bot on their pages.
- Curt Luttrell will continue to use the campus announcements to keep students informed.
- A digital newsletter will be developed.

3.2 Conclusion

Obstacles in communication on this campus, especially regarding the available student services, need to be solved; this includes gaps in inventory of our technology. There are several tools being discussed and developed to fill these gaps.

3.3 Professional development opportunities around personal connection

- Ways to encourage professional development: Incorporating it into Flex, having an adjunct congress?
- There is a need for more faculty advising on this campus.
- How can faculty be motivated to get onboard with advising? Collective bargaining agreements? Workload evaluation?

3.3 Conclusion (optional)

Another obstacle in our communication is the gaps in personnel inventory. We need to provide faculty with ways to develop themselves professionally. Also, accessibility to information on this campus is an obstacle. Having more faculty involved with student advising may help as statistics show that "Special Program" students are more successful because of their designated counselors.

3.4 Staying on the Path (or all GP?) Campus-wide messaging/branding

- We need a campus-wide cultural shift to realize that it's up to everyone, not just the students, for students to be successful; campaigning for this change is key.
- How do we deliver this message?
- Making our community aware of this change is important.

3.4.1 Possible campus-wide message: Goal setting for students

- Need to empower students with goal-setting skills.
- Need to tell students that both short term and long-term goals are important; changes to their goals are normal.

3.4.1 Conclusion (optional)

Data from last year's Focus Groups shows that 67% of students in the "Staying on the Path" phase feel isolated, discouraged, and unsupported. Staff and faculty uniting on a common message, such as the importance of goal setting and how to develop goal-setting skills, is one way we can better support students.
