3.1 Assessment Subgroup – Updates – Jorge Perez

- Planning of Flex presentation is currently underway. Collaboration with Dr.
 Martinez and the pillar team will provide faculty with instruction for a better
 understanding how to navigate the research, data, and assessment tools;
 along with what is available on the COD Institutional Research site.
- Pillar IV Co-Chairs along with the Data Evaluation Committee recommended
 Institutional Research webpage *Useful Links* link directly to the Guided
 Pathways *Data Success* essentially providing the same content and eliminating
 the need to update both pages. Additionally, Dean Espinoza-Parra asked for a
 subcommittee member of the assessment group to represent the pillar on the
 user-end workgroup.

3.2. Experiential Learning – Prudence Chase

Dean Espinoza-Parra reported he had met with VP Jeff Baker regarding the proposed Internship Program Manager. The positional will move forward recognizing the need for additional job description changes and the review of funding alternatives.
