



Information and Communication Technology Section 508 Compliance Review Process

Purpose

College of the Desert is required to apply [accessibility standards](#) to Information and Communication Technology (ICT) products and services in compliance with California Government Code Section 7405 and 11135 and Section 508 of the Rehabilitation Act of 1973. When content, systems, software or processes do not meet these requirements, an alternative access plan must be developed to address the accessibility barriers.

This form is used to document the review of ICT products and describe any alternate access plan if needed.

Instructions

1. Identify the business needs that the product will meet.
2. Provide a comparison of similar products and their features.
3. Evaluate the accessibility compliance level of the products being compared.
 - a. Review [School System to Make Websites and Software Accessible](#).
 - b. Include the vendor's [current Section 508 Voluntary Product Accessibility Template](#) (Section 508 VPAT) for each of the products being compared.
4. Describe the reasons for recommending the preferred product.
5. Complete an Equally Effective Alternate Access Plan (EEAAP) if the preferred product does not meet Section 508 standards.
 - The requestor is responsible for completing EEAAP Sections 1 through 3. For assistance, contact [Nicolás Crisosto](#), extension 4823.
 - The requestor must obtain the appropriate administrative approvals in EEAAP Section 4 and forward the signed form to Information Technology.
 - The requestor is responsible for providing copies of the EEAAP to those individuals identified in EEAAP Section 3, number 3, Responsible Person(s).
 - The Executive Director, Educational Technology or designee is responsible for forwarding the signed original EEAAP along with all associated ICT procurement documents to the Procurement Office, and maintaining a master archive of all EEAAP forms. Copies are available upon request.
 - An unsigned EEAAP form indicates the plan is not approved and must be revised for compliance with Section 508.
