I. CALL TO ORDER - Chair Wilson called the meeting to order at 9:30am and asked Trustee Jandt to lead the pledge of allegiance.

Vice President, Lisa Howell, requested to add Administrative Services, Action Item #4, Resolution #021017-1 of the Board of Trustees of Desert Community College District authorizing the negotiation of a contract to procure and install a telescope observatory at the East Valley Mecca/Thermal Campus without competitive bids.

Motion by Trustee Broughton, seconded by Trustee Stefan to approve the addition of Action Item #4 to the agenda as amended.

Discussion: Trustee Broughton requested further explanation as to why the addition is necessary to be added to the agenda. Vice President, Lisa Howell replied that the installation is required to ensure completion to comply with the outlined timeline. Should the item roll over an additional month, the installation of the item would not be deliverable to students in a timely manner. Trustee Broughton asked what the legal implications were along with obtaining competitive bids. Vice President, Lisa Howell, replied that legal counsel recommend the item be added to the board agenda to be safe as it was a sole source bid. Due to the complexity and scope of services, it required sole source bids. A search was completed throughout the United States and it was determined there were no other services available.

Senator Boxer agreed to come to the college campus to work with students in the future. 53 percent of students of UC and CSU students graduate with \$19,500 on average debt. That indicates there is a problem. The UC's are raising tuition. The Governor has proposed eliminated the middle class scholarship program. Tuition may raise in the CSU as well. Tuitions is a challenge and plEDGE is something that will be so important to our community.

He wanted to draw attention to other programs. American Dream Academy that ASU has involves over twenty thousand parents. The ceremonies are so moving watching the students to make the big step. He noted that we need to enlist parents to help encourage the students.

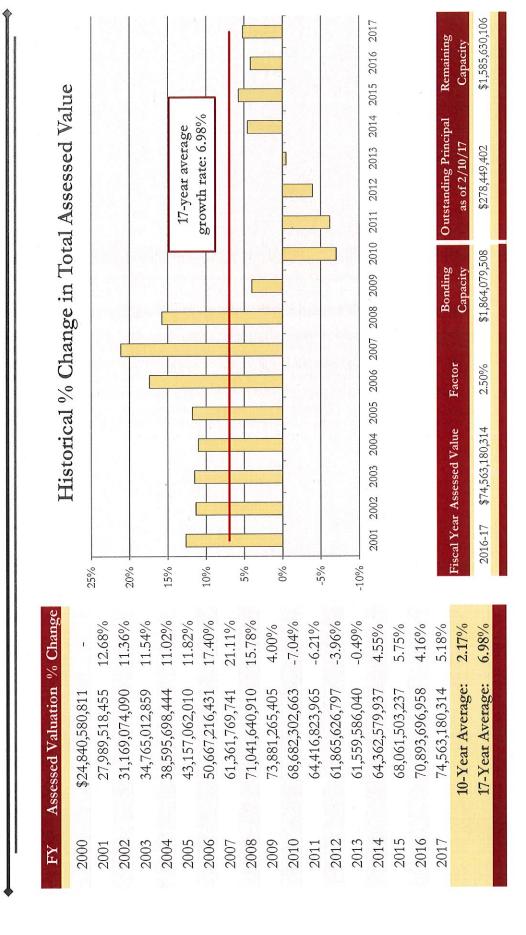

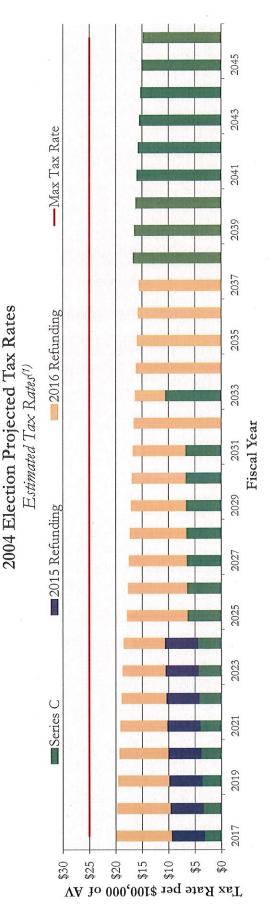

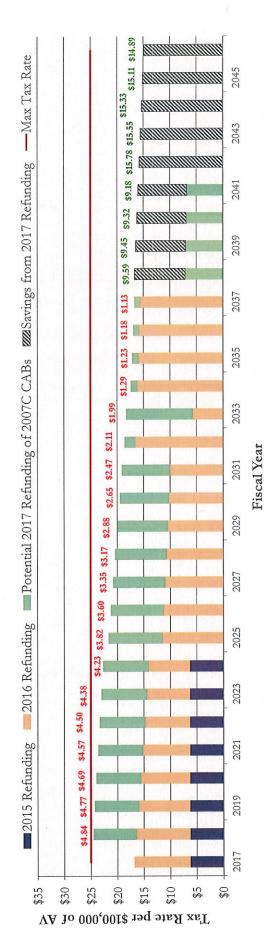
- The proposed structure results in negative gross savings from 2018-2037, but substantial positive savings from 2038-2046
- Additional taxes from 2018-2037 to be deducted from available 2016 Measure CC ad valorem revenues
- o No net increase in taxes between 2004 and 2016 Bond Measures
- ❖ Gross savings of \$194 million
- ❖ Net present value savings of \$55 million or 40% of the refunded par amount
- * Reduces the final maturity from 2046 to 2041, shortening the repayment term for the College's taxpayers



Post-Refunding 2004 Election Tax Rates

- ❖ 2017 Refunding Bonds would increase 2004 Election tax rates by approximately \$1.13 to \$4.84 per \$100,000 of Assessed Value ("AV") through 2037
- o Projected rates would not exceed the \$25 tax limit to college districts
- * Reduction in the final maturity from 2046 to 2041 would result in average tax rate savings of approximately \$12.70 per \$100,000 of AV from 2038-2046





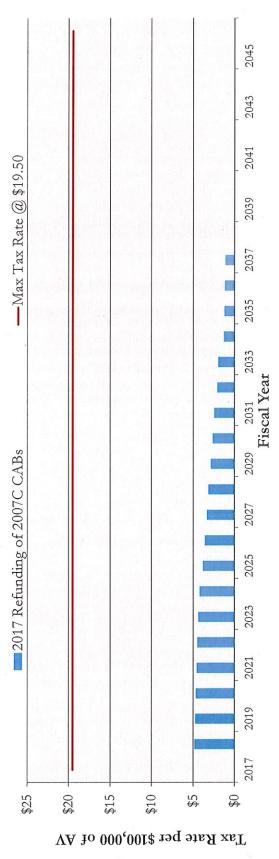

PUBLIC SAFETY AND SECURITY

80% of **firefighters**, **law enforcement officers and EMTs** are credentialed at community colleges. **39** colleges administer **Police Officers Standards and Training** (POST) academies. **64** colleges have **fire technology programs** for training firefighters.

NURSING

70% of the nurses in California received their education from community colleges.

SCIENCE, TECHNOLOGY, ENGINEERING AND MATHEMATICS

Transfer students from community colleges to the University of California account for **48%** of UC's bachelor's degrees in **science**, **technology**, **engineering and mathematics** (STEM).

ENROLLMENT

The enrollment of African-American students in California's community colleges nearly matches the undergraduate enrollment of the University of California. Nearly 1/4 of all Chicanas and Chicanos who receive doctorates first attend a community college.

VETERANS

More than 1/2 of California veterans receiving GI educational benefits attend a community college.

TRANSFER

Transfer students who come to UC perform well, persisting and graduating at rates similar to students who enter as freshmen. The average time-to-degree for transfer students is just over 2 years (2.4) after coming to the University (average time-to-degree for freshman is 4.2). Transfer students continue to be a successful and valued part of the UC community.
