I. CALL TO ORDER - Chair Stefan called the meeting to order at 9:31 am and asked Trustee Broughton to lead the pledge of allegiance.

II. BOARD MEETING AGENDA

Confirmation of Agenda: Approve the agenda of the regular meeting of August 19, 2015 with any additions, corrections, or deletions.

There were no more changes to the agenda, and the agenda stands approved as presented.

BOARD OF TRUSTEES CAMPUS TOUR – Chair Stefan announced that the Board of Trustees will be taking a brief tour around campus from 9:35 am to 10:15 am. Once the tour concludes, they will go into immediate closed session from 10:15 am to 10:30 am. The Board meeting will reconvene with open session at 10:45 am. President Kinnamon announced that an additional cart is available for any staff members wishing to go on the tour.

III. OPEN SESSION

Closed Session Report: no morning closed session.

Chair Stefan provided a brief report on the tour stating that the trustees visited the Walter N. Marks Center for the Arts center, the McCarthy Child Development and Training center, the

Stagecraft Shop, and the School for Applied Science and Business building. The trustees expressed their appreciation and thanked Mac McGinnis for guiding the tour and for his expertise.

IV. PUBLIC UPDATES

Public Updates – Dr. Kinnamon reported that they recently received the growth allocation projections from the Chancellor's office, and that the formula has been established at 8.68% growth for the District, the second largest percentage applied for the 2015-2016 year, creating ambitions goals for COD. Deans and staff have been working toward making this accommodation and adding additional sections for the upcoming fall, winter, spring, and part of summer, and if this growth was attained, it will create more access for the community, and could generate a great deal of ongoing revenue for the district. Dr. Kinnamon reported that COD is poised well for achieving our growth, stating that Indio already at its 1,000 threshold, and to accommodate further growth, staff has been evaluating the current facilities and classroom needs and looking for additional spaces available for use, including the possibility of temporarily utilizing space at UCR.

President Kinnamon reported that starting in January 2016, Sunline will be offering a dedicated COD express bus route from Desert Hot Springs to COD, and a presentation on this effort will be given at the September Board meeting. In the fall, COD students will be surveyed to determine transportation needs.

President Kinnamon discussed the ongoing operational budget, stating that additional personnel and faculty will be necessary to meet the need as growth continues and they will begin recruiting additional faculty. Dr. Kinnamon reported that the Academic Senate will hold its retreat this Saturday, and he briefly discussed ongoing budgetary needs for instruction.

- C. **Academic Senate** Dr. Kelly Hall was unavailable but submitted a written report to the Board of Trustees.
- D. C.O.D.F.A. (College of the Desert Faculty Association) Denise Diamond and Jose Simo were present and provided a brief report.
- E. **C.O.D.A.A.** (College of the Desert Adjunct Association) David Bashore was present and gave a brief report.
- F. C.S.E.A. (California School Employees Association) Lauro Jimenez was present and provided a brief report.

G. GOVERNING BOARD

Trustee Broughton – Trustee Broughton provided samples of dates from her date farm. She commented that she was honored to attend one of the EGDE celebrations; she emphasized how many hours and classes were saved through students taking these remedial classes, thanked the staff and applauded their work as well as the success of the program. Trustee Broughton stated that working toward solutions to student transportation issues was a big obstacle and is greatly beneficial to helping students reach their goals. Trustee Broughton stated that the tour this morning was terrific, and provided the trustees an opportunity to meet a few staff members.

Trustee O'Neill – Trustee O'Neill welcomed everyone back, complimented the ASCOD officers for attending the meeting today and thanked Carlos Maldonado for his leadership. Trustee O'Neill reported that open enrollment is beginning and there are changes that will affect staff. Trustee O'Neill thanked President Kinnamon for his leadership and thanked his fellow trustees for supporting COD as they continue to expand to meet the needs of the community, especially with the recent new thrust toward career and technical education. Trustee O'Neill thanked Diane Wirth and the human resources team for getting negotiations started early. Trustee O'Neill commented that he was appreciative of the tour of the facilities as facilities are critical to the success of COD and changes to the environment improve the learning process.

Trustee Wilson – Trustee Wilson thanked ASCOD for attending today's meeting. Trustee Wilson reported that she visited the EDGE program and complimented the boot camp, thanking Jessica Enders and staff for their work. Trustee Wilson reported that she

attended the vocational nursing program pinning as well. Trustee Wilson has begun tracking her units for the CCLC Excellence in Trusteeship Program, and that her attendance at ACCT Conference in New York earlier this year may be counted toward her certificate. Trustee Wilson thanked the college for supporting the upcoming Ophelia training in September, and commented that she is pleased to see COD's alliance with Sunline moving forward.

Trustee Sanchez-Fulton – Trustee Sanchez-Fulton thanked ASCOD officers for attending today's Board meeting, commenting that student leadership is critical. Trustee Sanchez-Fulton reported that she donated an iPad that she won at Las Vegas conference to one of the local schools, and shared a letter she received from Dr. Carreon Foundation. Trustee Sanchez-Fulton expressed her excitement about the Sunline partnership and the express bus from Desert Hot Springs to COD, and shared pictures of the ESL event held at COD that she also attended. Trustee Sanchez-Fulton stated that she attended the following:

- July17 attended Girlfriend Factor Summer Mixer. Dean Leslie Young and VP Lisa Howell also attended the mixer.
- July 23 attended joint chamber mixer of La Quinta, Indio and Coachella.
- July 24 attended Desert Hot Springs Chamber of Commerce administration signing of Incubator Program for desert lightning.
- July 31 attended a Riverside County Probation Resource Fair, where over 40 non-profits were represented.
- August 1st attended the 1st Annual California Teachers Summit at California State University, and provided her certificate of completion to the Board.
- August 2nd attended the Gary Bosworth luncheon, where State Controller John Chang and Secretary State Alex Padilla were keynote speakers. Trustee Sanchez-Fulton explained that Gary Bosworth was a Desert Hot Springs community leader.
- August 6th attended the Vocational Nurse Pinning ceremony as well the Summer Edge completion ceremony where 400 of COD's incoming fall students completed their 3-week program of fast-paced review of basic skills in Math and/or English.
- Attended COD ESL enrolling sessions on August 10 at Cathedral City High School and August 11 at Desert Hot Spring High School, and thanked the ESL team of Jessica Van Beers, Counselor Jose Simo, Dean Scott Cooper and Palm Springs Unified staff and community volunteers.
- On August 13th attended Indio Chamber of Commerce lunch where the Indio Chief of Police presented an innovative community outreach program. Trustee Sanchez-Fulton stated that she hopes to see him present this model program to COD.
- Trustee Sanchez-Fulton mentioned the concept of a charging station model for staff and students at COD, and commented that she is glad to see more classes added to our Desert Hot Springs, Cathedral City, Indio and Mecca campuses.

Trustee Stefan – Chair Stefan welcomed everyone back to a new school year. Chair Stefan reported that she represented COD at the recent CSEA state convention in Las Vegas where Lauro Jimenez won CSEA member of the year, and she brought back a plaque awarded to COD for display in a place of honor.

Chair Stefan announced that although Flex activities will begin next week, she also starts back to work next week, and apologized in advance for not being able to attend every Flex session. Chair Stefan Trustee urged the trustees to sign up for the CCLC Excellence in Trusteeship Program if they had not already done so, and informed the trustees that the parliamentary procedure session that will be offered during Flex will count toward their CCLC certificate. Chair Stefan also reminded the trustees that if for any reason they are unable to attend the October ACCT conference, to let Angela Walton know as soon as possible, and she shared copies of the individual trustee travel budgets for the year.

Chair Stefan stated that she is glad to hear negotiations are underway, and further commented that she will want to do another campus tour at an upcoming Board meeting. The trustees hope to hold a Board meeting in October at the Mecca/Thermal campus that will be held at a special time of day so that community members may attend.

IV. OPEN SESSION

Closed Session Report: Chair Stefan announced that in closed session, pursuant to Government Code §54956.9, the Governing Board has approved a Settlement Agreement between the District and SunPower Corporation Systems resolving a dispute regarding retention withheld by the District in connection with the parties' September 21, 2012 Solar/Photovoltaic System Project Agreement. In conjunction with the Settlement, Change Order No. 2 to the Agreement has been approved. The motion to approve was made by Trustee Broughton, seconded by Trustee O'Neill

to approve the settlement. The motion carried with 5 members voting in favor and 0 members voting against. Motion carried 5 to 0.

H. SUPERINTENDENT/PRESIDENT

Dr. Kinnamon asked Vice President Lisa Howell to present the Administrative Services Report.

Administrative Services:

- 2014-2015 fiscal year is now closed, unrestricted fund ending balance is \$8,137,519. Full budget report will be provided at the September Board meeting.
- Water Conservation Update COD continues to monitor, 2014 water usage dropped to 223 acre feet and 2015 usage is 108 acre feet through June.
- Bookstore Update 99.9% of expected needs are currently in stock.
- Year 2 Prop 39 Incentive Received SC Edison, received approval on incentive totaling \$71,635.92, slightly higher than projected.
- CPR Classes are offered by Director of Security, Tim Nakamura, and 24 staff members have completed the course.
- Wayfinding signs and road repairs completed. Trustee O'Neill asked if the wayfinding signs were in Braille – VP Howell will check on handicap accessibility and report back
- Parking Study VP Howell will bring a revised parking plan to next meeting

Human Resources - Vice President Diane Wirth reported on the following:

- COD Leadership Meeting: Leadership team met and discussed meeting formats, and developed a list of sixteen topics for future meetings. VP Wirth reported that the goal of these meetings is to strengthening internal networking within COD. Survey Monkey will be utilized for the meetings; the first meeting will be scheduled in September.
- Hiring Update: opened two Vice President positions, one for Instruction and one for Student Services, and they are advertising for these positions nationwide. The application period will close at the end of September 2015.
- Negotiations 2015-2016 negotiations have begun; they have already met with CSEA and will be scheduling negotiations with CTA and CODAA.

President Kinnamon reported on the following:

- Will try to have recommendations at the November meeting for the open Vice President positions, as well as several other positions
- Attended ASCOD retreat and complimented Carlos Maldonado, Director of Student Life, and the COD ASCOD students on their commitment
- EGDE Program 549 students were served over the summer; the program originally began with 22 students
- Through the Program Review Update process, over \$500,000 of instructional equipment has been approved and funded

- Flex activities begin next week, including President's address, new faculty orientation, and ongoing orientation for the fall semester with Dr. Berg and Zerryl Becker working on this.
- The trustees are invited to the Faculty & Staff dinner from 6-9:30 pm at the Omni Rancho Las Palmas next Thursday
- Central Campus renovations update
- Counseling, financial aid, and student services staff have done an exceptional job and have been focused on student needs
- Adjuncts at the pace COD is growing, acknowledged that adjuncts are significantly important to academic success of the students

Trustee Wilson asked if there would be follow-up on the long term impact of the EDGE program. Dr. Kinnamon reported that an analysis will be provided once the data has been assessed. Dr. Annebelle Nery, Executive Dean, reported that the sample size is important, and that it is a rich and diverse cohort, especially with hundreds of students to study. Once the analysis has been completed, the results will be shared with the trustees.

Dr. Tim McLarney of True North Research presented a Baseline Bond Survey presentation, which encompassed polling on feasibility of an additional general obligation bond. The purpose of the study was to determine if a bond measure is feasible, identify how to create a measure consistent with community priorities, and gather information needed for communications and outreach. Method of study was a telephone survey conducted June 26 through July 1, 2015. 400 District voters likely to participate in the November 2016 election were polled. Dr. McLarney explained the process of the ballot test and the sample of voters used. Key conclusions are that it is feasible to move forward with a bond measure on the November 2016 ballot. The ballot test needs to be 55% required to passage of Prop. 39 bond. Strong natural support was well above the 55% threshold (73%).

Charles Heath of TBWB Strategies discussed the Bond Planning Process and next steps. The first step is to build consensus, which includes informing and engaging the internal college community, including students, alumni, faculty and staff as well as campus leaders. The external community will also need to be informed, possibly by mass communication methods, to elected leaders, business leaders, ethnic community and voters at large. The next step is building the measure, which includes developing a detailed project list, develop a resolution calling for this election, a ballot question, a tax rate statement, and the Board vote. Next is an independent advocacy campaign, which will include private fundraising, endorsements, direct mail and advertising, phone banks, web/social media, precinct walks and lawn signs. The November 2016 Election Timeline: there are 157,426 registered voters, expected voter turnout is 130,266, and will need 71,647 votes to win the measure.

Adam Bauer of Fieldman, Rolapp & Associates briefly discussed four series of bonds as well as projected amounts that November bond sales done every few years through 2025 could generate for projects, which was approximately \$570 million. VP Howell briefly addressed the risks of engaging in this type of scenario.

Palm Desert Campus Tour – Board of Trustees took a brief tour of the COD campus, and will take another tour at a future meeting.

Trustee Broughton requested a study session on AB86. Trustee Wilson requested President Kinnamon's presentation on realignment and transportation. Trustee Sanchez-Fulton requested and update on technology.

<u>Tutoring and Academic Skills Center (TASC)</u> – On June 18, I reported that the Senate and administration had reached an agreement regarding proposed changes to the TASC. I reported that Dr. Nery and I had met on June 17, 2015 and agreed that since the TASC operations are directly related to student success and preparedness, a matter of Senate purview, no changes would be decided upon nor implemented at the TASC until the full Senate can take up the matter in the fall.

I also reported in June that Dr. Nery had been working with key faculty stakeholders to develop a job description for the Director of the TASC. It was agreed that an educational administrator position needed to be filled and that doing so would represent no substantive change to the TASC structure as this would essentially be the position vacated by Chris Nelson. The job description was developed, reviewed and agreed upon by June 16. However, the job description was not included for board approval at the July board meeting; it is on this month's agenda for your approval.

Katie Chartier has been asked to oversee the staff of the TASC until the Educational Administrator position has been filled. The Senate was not consulted about this decision. All of the TASC Instructional Support Assistants (ISA's) have been replaced with new hires. Chris Nelson has been contracted to train the ISA's. The Senate was not consulted about the decision to hire a consultant. Both of these decisions were made after the administration had committed to consulting with the Senate on the TASC transition.

Interviews for the TASC Tutorial Coordinator positions are scheduled to occur on Friday August 14. At this writing it is unknown whether any or all of the 3 positions staffed last spring will be filled for the fall term. What is clear is that when the new academic year begins, every instructional person employed there will have less than 30 days on the job. There will be no dedicated administrator. There will be an interim administrator, with no previous experience, that was appointed without faculty consultation.

<u>Enrollment Management</u> – The chancellor has recently released data indicating that College of the Desert's growth rate last year was the 2nd highest in the state. We are now in a positon to receive a substantial increase in growth funding. This is good news but we must move forward in a measured manner so that our schedule reflects the mission of the college and so that such things as maximizing apportionment do not drive curriculum or other decisions. ¹

For example, in recent days, 24 sections of ELSN courses were added to the schedule. Neither the department chair nor the discipline faculty was consulted. Demand for these classes is unknown (as of this writing most remain zero or very low enrolled) and with the semester start 2 weeks away, many have no assigned instructor. It may be that adding these sections is a sound idea. But dramatically increasing the sections offered in a program right before the start of a new term, with unproven basis for estimating fill rates, and without faculty consultation, is a troublesome approach to enrollment management.

Academic Senate – The Senate executive committee will hold its fall retreat on August 22. The purpose of this gathering is to articulate and clarify Senate goals and priorities for the coming year. Dr. Kinnamon has accepted our invitation to attend the afternoon session so that we may share and discuss the Senate's vision for 2015/16. These goals and priorities will be communicated to the campus community during the Senate 101 session during Flex (Thursday,

¹ Curriculum is more than writing a course outline. Curriculum includes sequencing of courses, delivery method, degree and certificate requirements, student preparation, pre-requisites and more. Therefore, the faculty must be major participants in setting the academic directions for the college, including enrollment management and scheduling policies.

August 27 from 1-2:30, Cravens' Multi-purpose Room). I will also include the 15/16 Senate agenda in my September board report.

The California Community College system is divided into districts for purposes of state Senate representation. College of the Desert is in area D. This fall, our college will host the annual area D meeting. On October 24, approximately 50 Senate presidents, faculty leaders, and state representatives from area D will meet on our campus to discuss current issues, articulate faculty positions and share best practices. This is a great opportunity to showcase our college and programs. The meeting is on a Saturday so our guests will be treated to lunch from one of our Street Fair lunch vendors, Julio Cruz. Julio is a College of the Desert and CSUSB business graduate who serves the best burritos and carne asada in the desert. Chef Beno's culinary students will prepare desert. Our horticulture students will provide living center pieces for the tables and Dr. Kinnamon will be on hand to welcome the group.

<u>SSSP Non-Credit</u> — On July 20, 2015, College of the Desert received a memorandum from the Chancellor's office. The memo was notification that colleges must certify that they will provide core SSSP services to noncredit students and also that they will submit a noncredit SSSP Plan and Budget for 2015-16.

The certification form indicating the college currently administers a noncredit SSSP is due on Monday, August 17. The plan is due by October 30, 2015. Both the certification and the plan with budget must be submitted on time in order for colleges to receive funding for SSSP services to non-credit students in 2015/16.

I contacted Professors Renat Senters and Fred Vescial, both tenured faculty in the ESL non-credit area. Given the tight time frames, both agreed to help out over the summer. Amanda Phillips formed a working group that met on Tuesday, August 4th. The group discussed the current services offered to non-credit students regarding Orientation, Assessment, Counseling and Educational Planning and Follow-up. They identified gaps in services and decided on next

steps for addressing these. The group got off to a great start. Hopefully this work will continue on-track now that Amanda Phillips is on leave.

Thank you very much to Professors Vescial and Senters for their speedy response to this need. I'd also like to recognize the dozens of faculty members who have served on hiring committees this summer, those that have worked to organize Flex, chaperoned student field trips, been active in state Senate events, consulted on the TASC structure and more. College of the Desert has an amazing team of dedicated faculty!

Desert Community College District Board of Trustees' Meeting August 19, 2015 CODAA Report

As mentioned in Dr. Hall's Academic Senate report to this board, English as a Second Language – Noncredit (ESNL) has made dramatic, last minute additions and changes to the class schedule. In addition to the impact this has on curriculum as stated by Dr. Hall, this action was also a violation of the Adjunct collective bargaining agreement. Article VI, Section 7 states, "Every effort will be made by the District to obtain written or oral consent of the assignment(s) from the Adjunct Faculty Member prior to the distribution of the class schedule." This was not done. The class schedule that currently appears to the college and the public, is a placeholder Spring Semester schedule plus 24 new offerings (traditionally Fall for ESLN is different than Spring as students complete Fall then move up to Spring if they pass). No current adjuncts or new adjuncts have received load sheets.

The collective bargaining agreement further states, "Adjunct Faculty Members who taught the previous semester, shall be notified of hiring or non-hiring no less than thirty (30) calendar days prior to the start of the Fall and Spring Semesters." This was not done.

I wish that I could tell you that this is an unusual exception to the rule, but it is not. For many years now, Adjuncts in ESLN have not been treated with respect or professional courtesy. In addition to the above examples, they are kept in the dark about other important matters, they are given mis-information, unreasonable demands are made on their (uncompensated) time, and their pay rate is lower than any other Adjunct rate. Many of our ESLN Adjuncts have taught at COD for up to 25 years. Their dedication to the college and its students is unquestioned. They should be shown the same respect as any other group of faculty or college employees.

We also echo Dr. Hall's concern about TASC. And once again, Adjuncts (and students) are the most severely impacted by the mismanagement of the tutoring center. Adjuncts were told that they no longer had jobs, without explanation as to why. And while CODAA is keenly aware of that fact that we have absolutely no job security, a matter that has been brought to this Board's attention on numerous occasions, it is yet another example of the disregard and lack of respect for Adjuncts.

CODAA is still waiting for scheduling of negotiations on several critical and timesensitive issues. We have been available all summer but still have not settled distance learning, overlay classes, and stipends. These issues are not being appropriately administered and have resulted in, and probably will continue to result in, formal grievances.

As the college continues to grow, so do the ranks of adjuncts. With new adjuncts being added to the payroll on a weekly basis, we represent a large and important constituent group. And again, kudos to HR for the excellent job they've done in bringing all these people on board. CODAA members recently voted to go "fair share" or "agency fee" which means that all

adjuncts will be paying fees to CODAA, whether or not they choose to join the union. With this change we expect even greater participation among Adjuncts in the shared governance process.

Congratulations are in order for the outstanding growth in FTEs and the resulting increase in funding. Everyone in the District should be proud of this accomplishment and should work together to meet the challenges that this growth creates.

CODAA will be offering three programs at Fall Flex specifically for Adjuncts. We will also be hosting welcome back coffee and donuts receptions on Wednesday and Thursday mornings of Flex, to which all of you are invited.

Since no one from CODAA was available to speak at the last Board meeting, I want to reiterate our pleasure with the agreement reached on the details for implementing "pay-per-course" that was negotiated one year ago. We would like to thank everyone involved in the process, especially Lisa Howell, Diane Wirth and John Ramont.

As stated in previous reports, last year was challenging on many different levels, but significant progress was made. We look forward to a new year of continued progress that can only be achieved if we all work together, and not against each other.

ADMINISTRATIVE SERVICES STAFF REPORT AUGUST 19, 2015

Topic: Financial Update

I am pleased to report our 2014-15 fiscal year is now closed. The Unrestricted Fund ending balance is \$8,137,519 or \$946,463 higher than projected in the Tentative Budget. This increase in fund balance was primarily due to unanticipated revenues related to the FTES settlement. The 2015-16 Budget will be presented at the September 18th board meeting.

Topic: Water Conservation Update

COD continues to monitor water usage carefully to ensure we remain penalty free by reducing the 2013 usage of 346 acre feet 25% for non-potable (well) water and 36% for potable (domestic) water. The 2014 water usage dropped to 223 acre feet and the 2015 usage is 108 acre feet through June. Jason Arebalos is assembling a task force including representatives from other educational agencies to share information and develop strategies toward this effort.

Topic: Bookstore Update

Great news from our staff at the Bookstore. As of the beginning of this week, 99.8% of expected courses had been entered and 98.1% of expected titles. Topping this is tough to do but reports indicate our bookstore has 99.9% of the anticipated need is in stock and available for students and staff. Pell Financial Aid "vouchers" will be available Monday morning for students providing over 1800 students with bookstore credit of \$250 or \$500. Students will be emailed on Monday or Tuesday informing them of their specific voucher amount. Staffing has been increased by 28 store associates to handle to expected increase in activity.

<u>Topic:</u> Year 2 Prop 39 Incentive Received

Southern California Edison notified us in late July of their approval for Year 2 Proposition 39 Incentive projects. The incentive totaled \$71,635.92 which is slightly higher than projected. The projects included parking and walkway lighting and the installation of control systems to enhance our ability to manage the lighting on the PV carports. As you know we have received a small number of complaints. The new control system will allow us to schedule on and off times by schedule or photocell.

Topic: CPR Classes offered by Director of Security, Tim Nakamura

Staff at our Palm Desert and Indio campuses were provided the opportunity to obtain or renew the CPR skills. Approximately 24 staff completed the course and more classes are available upon request.

Topic: Way Findings and Road repairs complete
















HUMAN RESOURCES STAFF REPORT AUGUST 19, 2015

COD Leadership Meeting





n addition to fueling our economy, COD graduates spend much of their income right at home – a net impact of \$29.3 million each year. And it's not just graduates who are spending. COD staff and faculty contribute too: salaries stream directly into the local marketplace annually at an amount of \$39.6 million.

For every dollar of support for the College of the Desert, taxpayers see a cumulative return of \$1.40 over the course of students' working careers (in the form of higher tax receipts and avoided social costs).

Regional Plan for College and Career Readiness

College of the Desert is a significant and committed partner in the Coachella Valley Regional Plan for College and Career Readiness. The plan was developed with over 75 stakeholders, including the Coachella Valley's three K-12 school districts, Riverside County Office of Education, Riverside County EDA/WIB and industry leaders from across the region. This five year plan aligns the resources of the business, community and education partners to support college and career readiness via a pipeline

strategy focused on developing seamless K-University education pathways to prepare valley students for careers in industry clusters which hold great promise for high-wage, high-skilled jobs and economic growth.

Working with these same partners, College of the Desert is also leading the AB 86 Regional Consortium's efforts to develop a strategic plan for providing Adult Education in the region.

Strong Community Engagement and Support

In recent years, the COD Foundation has stewarded more than \$25 million in private gifts and grants to support College of the Desert – funding made possible by the generosity of corporations, foundations, Alumni, parents and philanthropists. In 2014, in honor of the Foundation's 30th Anniversary, the "Changing Lives Campaign" set an ambitious goal to raise \$3 million over 30 days. The campaign focused on raising funds for scholarships, the Bighorn Golf Club Charities Veterans Resource Center, student support programs and instructional innovation. When the final figures came in, the total raised was more than \$3.5 million.
