He stated he was asked to complete a lecture that started at 6:00 pm and at approximately 6:05 PM. The campus was placed on immediate lockdown. He noted the incident was several buildings away and he continued with his lecture, which brought them to about 7:00PM. At 8:00 PM they still had received no information, twelve of them left to theirs cars. Trustee Jandt stated that failure to communicate with people who are possibly in their offices and classrooms is a challenge. Improvement can be made to the communication process. The absence of receiving no information. He hopes this type of activity ends on all campuses.

Accreditation, seven years without a subsequent visit is wonderful news for the College. Trustee Jandt thanked everyone for getting the Temporary Palm Springs Campus up and running.
