# III. Financing Corp. Action:

### 1. District Designated Director Appointments

Larry Salas made a motion to accept appointments for Jeff Baker and Bea Gonzalez as the District's Designated Directors, seconded by Glenn Miller.

Discussion: Due to the retirement of former District Director, Dr. Joel L. Kinnamon, Superintendent/President at College of the Desert, Glenn Miller, City of Indio Councilmember, nominated Jeff Baker, Interim Superintendent/President at College of the Desert. At College of the Desert's December 18, 2020 Board Meeting, the Board of Trustees appointed Trustee Bea Gonzalez to serve on this Board.

## 2. Non-District Designated Director Appointment

## 3. Approval of Minutes from October 2, 2020 Meeting
