This course provides information on evaluating and reporting incident conditions, analyzing incident needs, developing and implementing a plan of action to deploy incident resources, completing all operations to suppress a wildland fire, establishing an incident command post, creating an incident action plan, and completing incident records and reports. Upon successful completion of the course, a CSFM diploma fee of \$140 is required for this course to cover the California State Fire Training Certificate of Completion.

#### **Schedule Description**

This course provides information on evaluating and reporting incident conditions, analyzing incident needs, developing and implementing a plan of action to deploy incident resources, completing all operations to suppress a wildland fire, establishing an incident command post, creating an incident action plan, and completing incident records and reports. In the hybrid format, students will be given reading and research assignments that will be discussed through the use of zoom or via face-to-face meetings. Lectures will be conducted through zoom, with the ability for students to ask questions and interact with the instructor. The LMS will host all assessments so that feedback can be timely and accessible at any time. Office hours will be offered with an instructor available for any questions the students may have. Additionally, the online portion of the hybrid class will be via zoom in a synchronous modality. This is a requirement through State Fire Training, our accrediting agency.

Zoom will be used for synchronous audio and visual interaction with the instructor. Lectures will be delivered in this format, as well as hosted discussions.
