- · ANA Gerontological Standards of Care & Federal and State Regulations (AANC Ess V)

Health Maintenance & Promotion and Alterations in Health of Geriatric Client

- Normal physiological aging changes
 - Sensation, Vision, Hearing
- Neuro, Respiratory, GI (Nutrition/Hydration/Barrier to adequate Nut/Hyd Hartford #5), GU (Urinary Icont Hartford #5), Musculoskeletal, Integumentary (Hartford #4)
- Use of evidence-based assessment instruments (AACN Essential III) (eg. Braden scale (Hartford #4)
- Promote quality of care, and safety & injury prevention (eg. falls, Beers Criteria, pressure injuries AACN Essential II)
- · Common risk factors that contribute to functional decline, impaired quality of life, and excess disability in older adults
- · Quality end-of-life care for older adults, including pain and symptoms management.

Alterations in the health of older adults:

- Risk assessment using evidenced based assessment instruments (MMSE) (Hartford #2)
- Alzheimers vs dementia vs delirium vs cognitive impairment, depression in the aging adult eg. Geriatric Depression Scale GDS (Hartford Comp #2),
- Examine the implications of increasing death by suicide amongst the gerontological population.
- · Alterations in health to include diet, medication, exercise, home management.



- Evidence based practices to assess pain and intervene for the cognitively impaired patient if pain is to be expected (Hartford Comp#3)
- · Chronic illnesses characteristics
- Poor surgical outcomes
- · Identify geriatric syndromes common to older adults.
- Determine characteristics of chronic illness and their impact on the gerontological client. Medications and CAMs
 indications, actions, contraindications, side effects, adverse effects, BEERS criteria
- · Nursing implications are commonly used for the gerontological client.
