Objective 12	Discuss the role of members of the health team that collaborate and coordinate care for the critically ill client to promote optimum wellness.
Objective 13	Describe effective and non-effective styles of communication used when making client assignments.
Objective 14	Analyze how the use of informatics can be used to prevent errors and improve quality and safety.
Objective 15	Identify evidence-based procedures that focus on the early identification of sepsis and how it relates to quality improvement
Objective 16	Correlate risk factors that influence infection control in the critical care client and identify quality improvement strategies used in the critical care setting aimed at improving outcomes
Objective 17	Incorporate safety factors in the nursing management of clients with alterations in level of consciousness, mobility, perception, and cognition.
