### **Catalog Description**

This is the first full-time clinical assignment in the PTA program in which students perform delegated patient care responsibilities in a physical therapy clinical setting, under the supervision of a licensed physical therapist. Students will practice the application of physical therapy procedures according to the setting such as the acute, sub-acute, outpatient, skilled nursing, or other type of physical therapy/rehabilitation clinical facility. Facility will be assigned by program faculty. Limitation on enrollment: Admission to the Physical Therapist Assistant (PTA) Program

### **Schedule Description**

Physical Therapy Assistant (PTA) students will complete a clinical affiliation at a clinical facility assigned by the program faculty. Days, hours, and facility will vary.

#### **Requisite Course Objectives**

PTA 003-Explain and demonstrate proper utilization of devices and equipment such as assistive/adaptive devices and prosthetics and orthotics following evidence based practice while educating patients and caregivers.

PTA 003-Illustrate proper patient education on body mechanics and technique when performing functional training in self-care and in domestic, education, work, community, social and civic life while performing in a competent and ethical manner.

PTA 003-Demonstrate effective communication with patient/client caregiver and family to obtain current level of function, health and performing patient education while respecting differences, values, preferences and expressed needs with patient conditions commonly seen in the inpatient setting.

PTA 003-Demonstrate effective utilization of measurements of vital signs and responses to positional changes and activities and interpret results to identify when an intervention should not be performed and report changes to physical therapist.

PTA 003-Demonstrate and describe how to perform measurements for height, weight, length and girth and be able to detect changes in patient's state of arousal, mentation and cognition and evaluate integumentary integrity: detect absent and altered sensation, normal and abnormal integumentary changes, activities, positions and postures that aggravate or relieve pain or altered sensations, or that can produce associated skin trauma and recognize viable versus nonviable tissue as commonly seen in the inpatient setting. PTA 003-Interpret finding of muscle performance with manual muscle testing, muscle tone and presence of muscle mass to help determine safety, status, and progression of patients while engaging in gait, locomotion, balance, wheelchair management and mobility.

PTA 003-Demonstrate proficiency in implementing selected interventions in wound management including: isolation techniques, sterile techniques, application and removal of dressing or agents, and identification of precautions for dressing removal.

### **Entrance Skills**

Effectively apply treatment techniques in the outpatient setting



#### **Requisite Course Objectives**

PTA 004-Demonstrate and describe effective manual therapy techniques, such as passive range of motion, therapeutic massage, joint mobilization and therapeutic exercise.

PTA 004-Explain safe and effective use of biophysical agents, cryotherapy, hydrotherapy, superficial and deep thermal agents, biofeedback, electrotherapeutic agents, compression and demonstrate proper use and identify contraindications.
PTA 004-Demonstrate patient education skills to explain selection of interventions prescribed by physical therapist in POC.
PTA 004-Demonstrate ability to recognize normal and abnormal joint movement, trunk and extremities alignment and ROM.
PTA 004-Illustrate ability to document physical therapy treatment results in SOAP (Subjective, Objective, Assessment and Plan) notes and grid formats.

- 5. Patient Treatment Protocols
  - a. Arrange the treatment room and table appropriately
  - b. Position and drape the patient for comfort and for correct exposure of the part to be treated
  - c. Explain the treatment and checks for contraindications.
  - d. Select correct transporting device
  - e. Choose correct gait and assistive device according to therapist's intervention plan
  - f. Adjust equipment to correctly fit the patient
  - g. Check equipment for safe use.
  - h. Select appropriate gait pattern according to plan and diagnosis
  - i. Demonstrate to the patient, and family if appropriate, the gait pattern and management of the gait device
  - j. Spot the patient using safety belt, good body mechanics and correct hand placement
  - k. Teach correct techniques for stairs, curbs, ramps, doors and other architectural barriers
  - I. Properly administer physical agent modalities
  - m. Identify the appropriate technique from medical record and/ or discussion with therapist
  - n. Perform goniometric measurements and gross muscle tests to the extremities for data collection
  - o. Record and communicate observations and findings
  - p. Perform postural drainage on respiratory patients
  - q. Instruct patient/family in assigned treatment regime
  - r. Instruct patient in exercise routines as directed by the physical therapist
  - s. Identify and perform shared departmental responsibilities



t. Contribute to the discontinuation of episode of care planning and follow-up processes as directed by the supervising physical therapist

- 1. Weekly reading based upon clinical patient treatments.
- 2. Homework as assigned by the clinical instructor/course instructor.

#### Projects, Activities, and other Assignments

- 1. Field work in the clinical environment treating patients with orthopedic, neurologic, and general medical diagnosis.
- 2. In-service presentation to clinical staff on patient treatment diagnosis, physical therapy treatment techniques, or medical diagnosis.
- 3. Tracking of clinical hours during the clinical rotation and completion of the clinical site information form as required for CAPTE PTA program accreditation requirements.

#### Writing Assignments

- 1. Weekly journals reflecting on what the student experienced/learned, identifying weekly goals and methods on how to achieve the goals, along with identifying areas of clinical improvement.
- 2. A sample treatment note to gauge progress towards skilled, defensible documentation.
- 3. Weekly clinical goal setting with the clinical instructor.
- 4. In-service presentation to clinical staff related to a relevant physical therapy topic of value to the clinical setting/staff.
- 5. Clinical instructor and site evaluation for ongoing continuous program/clinical improvement and CAPTE PTA Program requirements.
- 6. Midterm and Final written self evaluation of clinical patient experience and learning experience.
