2.3 The Vision Resource Center - Donna Greene

The Vision Resource Center is a professional development portal to deliver and track activities across all sectors of a campus community. The project meets a variety of goals set by all four pillars, and how each pillar can benefit from this professional development plan.

Proposals:

- Project 1. Set-up portal welcome pages and begin tracking activities and training. Stipend; up to 40 hours.
- Project 2. Create/curate professional development materials for staff, full-time faculty and adjunct faculty within the Vision Resource Center. 3 stipends up to 40 hours each.
- Project 3. Create a Canvas online Professional Development course using ASCCC Guided Pathways Canvas courses based on principles of Entering, Clarifying, and Staying on the Path with materials for classified, full-time, and adjunct faculty. Stipend: Up to 40 hours for creation of Canvas Shell with Guided Pathways principles.

Consideration of a short-term staff position providing ongoing support is a possibility for the overall project.

Projected Cost: Up to \$18,000.00 upon completion of all three projects.

Conclusion: Motion, second to approve funding request. Unanimously approved.
