1. Call to Order

Jeff Baker called the meeting to order at 12:03 p.m.

We moved Item 3.5 up front on the agenda.

- 3.5 VP Baker gave an update on Guided Pathways
 - Shared the document Guided Pathways Update
 - We had developed an institutional framework
 - Vision Statement: It takes an entire campus community to maximize student success.
 - Make sure we use data when making decisions.
 - We need to focus on six factors to maximize student success:
 - Directed: Students have a goal & know how to achieve it.
 - Focused: Students stay on track; keeping their eyes on their end goal.
 - Nurtured: Students feel that somebody wans and helps them to succeed.
 - Engaged: Students actively participate in class and extracurricular activities.
 - Connected: Students feel they are part of the college community.
 - Valued: Students' skills, talents, abilities and

experiences are recognized.

- When you think of Guided Pathways; it is supposed to be about from access to completion.
- The State is asking us to look strongly at equity data. That is why Amanda and her role with the Equity Committee is so important and that we are integrating that into this work moving forward.
- Donna Greene brought up the CPC conversation about reimagining our schedule by having multiple starts and multiple semester lengths (6,12 & 16 week classes).
 - This could become a great dialogue and easily get students involved in that discussion.
 - We can blend it into one of the GP levels and make those recommendations to the Calendar and Ed Policies committees.

PILLARS -

- I. Program maps and metamajors will be helpful Maybe we re-frame Pillar I to be more about access to the institution. Outreach and marketing.
- II. Helping students choose and enter the pathway creating multiple start dates in the semester would be helpful for students
- III. All of our services help the students stay on the path -

Matt mentioned that there are delays for students applying and receiving their student ID numbers. Sometimes it takes up to 72 hours. It is two days quicker at Barstow with online applications. We need to determine if the delays at COD are technology related or staffing?

- a. Matt asked about our counseling department reaching out to students.
 - i. We do reach out to the new students EDGE/pIEDGE and get them an abbreviated plan and then start inviting them to the open labs or to meet with a counselor to do additional plans.
 - ii. Now students that get to Level two probation are assigned to a counselor and are required to meet to do a success contract before registering for the next semester.
- b. The Early Alert system by Connect-Ed is going to be releasing the improvement within a week. COD already owns it. This integration into Canvas will enable the faculty to be alerted from their rosters in Canvas.
- IV. This is to ensure that learning is taking place with intentional outcomes. This could be our ongoing support of ACUE.

- 2.3 Approval of Funding Requests: Donna presented the following request.

3. Information/Discussion Items

Suggested to do a survey of students; perhaps at GradFest to gauge our institutional outcomes.

We could expand dual and concurrent enrollments to obtain more students.

Use a different approach with students; have them apply while we are with them. Instead of the student having to stop at five different places, have one place where there is a person from each area that can engage with them similar to an Apple store set up.
