## **Nursing Leader Appointed to Oversee College's Mathematics and Sciences Division**

**PALM DESERT, CA (February 9, 2026)** -- College of the Desert (COD) has appointed Sarah Fry as Acting Dean of Mathematics and Sciences, bringing data-informed leadership and extensive healthcare education experience to this pivotal role. Fry will provide oversight for the division's diverse programs, including mathematics, sciences, nursing, and allied health.

Fry will offer both instructional and administrative guidance for the division, overseeing faculty evaluation processes, curriculum development, scheduling, enrollment management, and resource allocation. Her responsibilities include ensuring accreditation and regulatory compliance while maintaining continuity during this period of transition.

A tenured faculty member who joined COD in 2012, Fry has steadily advanced through positions of increasing responsibility. Her trajectory includes service as SLO Coordinator, supporting outcomes assessment and continuous improvement initiatives; Department Chair; Assistant Director of the Registered Nursing Program; and Director of Nursing and Allied Health.

"Sarah brings a unique combination of clinical expertise and administrative acumen to her new role," said COD Superintendent/President Val Martinez Garcia. "Her proven ability to align programs with workforce needs and institutional priorities makes her exceptionally qualified to guide this vital division."

Fry earned both her Bachelor of Science in Nursing and Master of Science in Nursing with a concentration in nursing education from California State University, San Bernardino. Her clinical career was spent in intensive care settings, where she also served as a clinical nursing instructor, combining hands-on patient care with educational mentorship.

"I am honored to serve in this capacity and to work alongside our talented faculty and staff," said Fry. "My focus remains on supporting instructional quality and student achievement while ensuring our programs meet the evolving and growing demands of healthcare and STEM fields."

Known for her evidence-based approach to decision-making and unwavering focus on student outcomes, Fry's appointment underscores the college's commitment to placing experienced leaders in key positions that directly impact learner success and program quality throughout the Coachella Valley region.

Fry's appointment was made official at the COD Board of Trustee's regular meeting in January.
